Notice under section 249D

2013 and has concluded that the notice is invalid.

As per s 249D of the Corporations Act, a request by a member for the calling of a general

meeting by directors must be signed by the members making the request. As per s 231, a

person is a member of a company if their name is entered on the register of members.

Admiralty has reviewed its share register and the person signing the request under s 249D

received on 6 March 2013 is not named in the Company's register as being a holder of at

least 5% of the Company's issued capital. As a result, the notice under s 249D is considered

invalid.
